I warrant that my dog is current with the vaccinations required by law and that my dog is healthy to the best of my knowledge.

Matted Dog Policy: Dogs with matted coats will require extra attention. If the matting is minimal and the dog responds well we may demat for an extra fee. However, if the matting is severe the least painful and stressful way to remove the mats is by shaving the dog. There is a greater risk of nicking, cuts or scratching a matted dog during the grooming process. In addition, the skin may appear red, itchy and irritated due to the lack of oxygen reaching in and under the mats.

Noni's will not be held responsible for any injury sustained while grooming a matted dog, including any after effects. This includes, but is not limited to swelling, redness, itchiness and self-inflicted abrasions due to external rubbing.

Accidents: Every effort will be taken to make sure your pet gets groomed as safely and carefully as possible. But, unfortunately, accidents DO happen. Dogs are licking, scratching, jumping, and overall wiggly creatures. Whereas dog grooming tools, by necessity, are sharp instruments. If there is a severe mishap we will contact you immediately but will take the necessary measures to get your pet the medical attention he/she requires. Noni's will not be responsible for any costs related to this. If my pet is hurt or becomes ill, Noni's Pet Boutique & Grooming has permission to call or take my pet to a veterinarian, administer medication, or give other advisable attention with our discretion and judgment. Such expenses will be paid promptly by owner unless injury is a direct result of negligence of Noni's Pet Boutique & Grooming. We will not be held responsible for any accidental death of a pet, including those related to pre-existing health conditions or natural disasters. We reserve the right to charge additional for services we consider over and above the norm, covered by our standard rates. We also reserve the right to refuse service to customers whose pet may pose a threat to us or to other pets left in our care, whether it is an aggression problem, health problem, or parasite.
